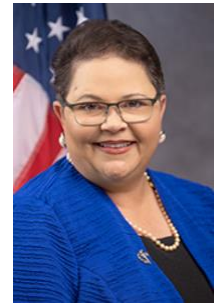

DRAFT LEGISLATIVE PRIORITIES

TAX COLLECTOR BUDGETS

Support amending s. 195.087, F.S. relating to Tax Collector budgets:

- **Budgets must be submitted by June 1 annually;**
- **County Commissions will provide comments to Dept. of Revenue (DOR);**
- **DOR will consider BCC feedback and respond to all comments provided;**
- **Final budget must be provided to BCC.**

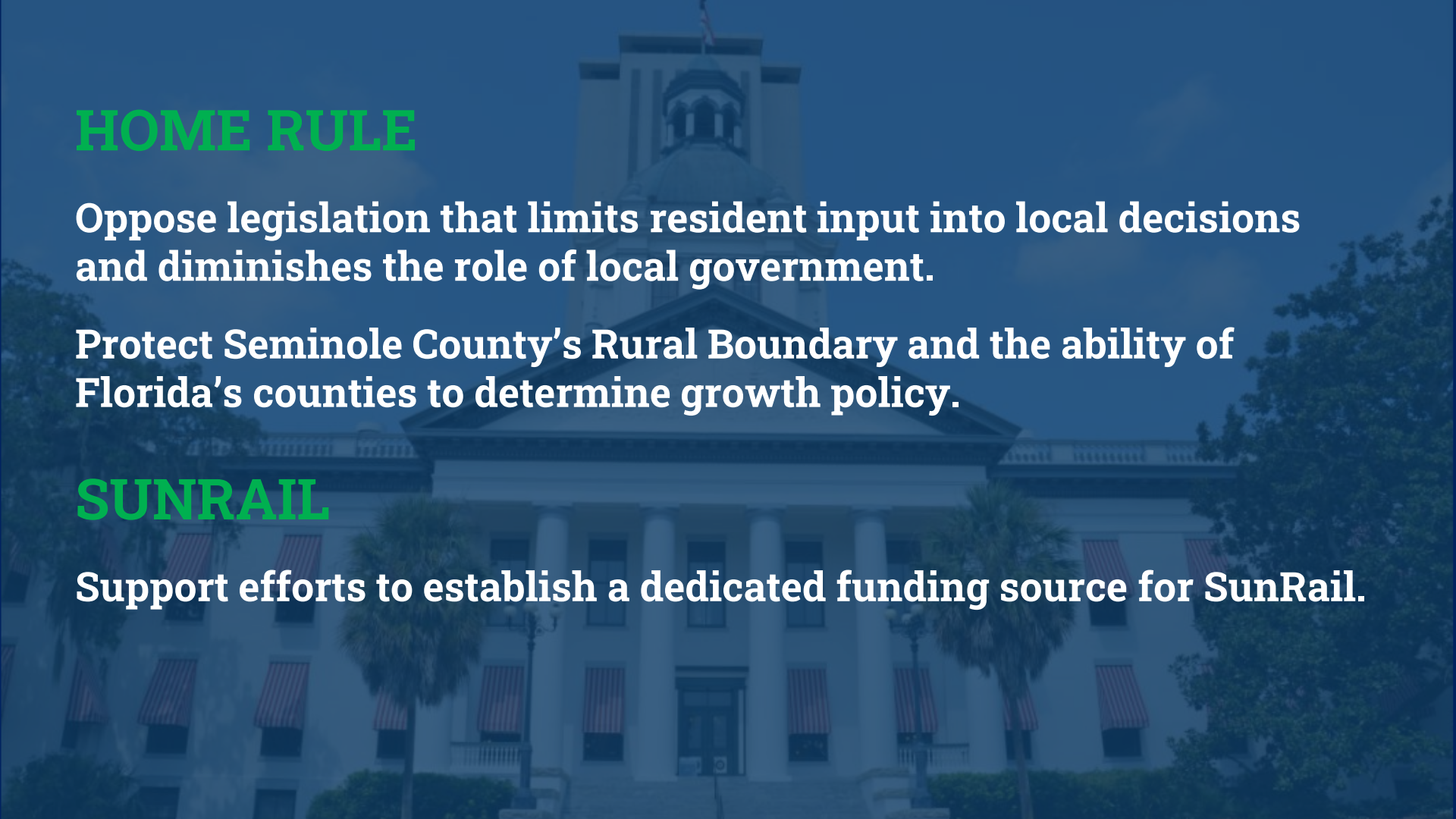
WATER RESOURCES

Support increased funding for local water infrastructure projects with direction for coordinating the various state/regional entities funding water issues toward local priorities.

Support recurring funding for programs that move private septic tanks to public wastewater collection systems.

PUBLIC RECORDS EXEMPTION

Support amending s. 119.071, F.S. to grant a public records exemption to allow the protection of any personal identifying information of an applicant for County Administrator/Manager/Coordinator and County Attorney.



HOME RULE

Oppose legislation that limits resident input into local decisions and diminishes the role of local government.

Protect Seminole County's Rural Boundary and the ability of Florida's counties to determine growth policy.

SUNRAIL

Support efforts to establish a dedicated funding source for SunRail.

MONITOR

- **Initiatives that support funding for State Digital Equity grants**
- **Efforts to expand Florida's Prescription Drug Importation Program to private and government providers**
- **Impacts on Sovereign Immunity limits and processes for claim resolution**
