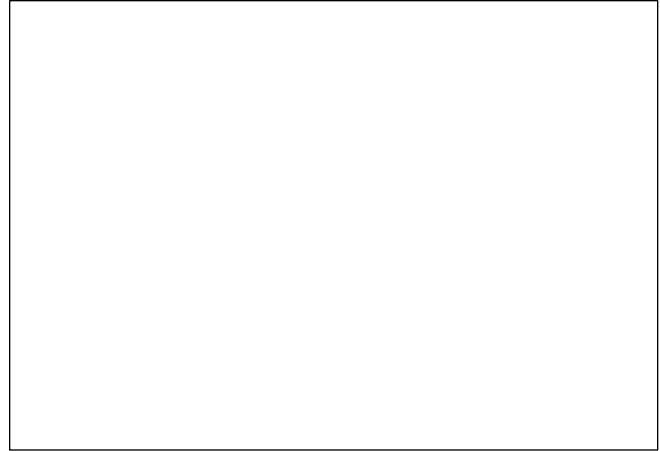

**CORRECTIVE COUNTY DEED  
COUNTY OF SEMINOLE, FLORIDA**

**THIS CORRECTIVE COUNTY DEED** is made this \_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, by **SEMINOLE COUNTY**, a political subdivision of the State of Florida, whose address is Seminole County Services Building, 1101 E. 1<sup>st</sup> Street, Sanford, Florida 32771, hereinafter referred to as “GRANTOR”, and **NEW TRIBES MISSION, INC. n/k/a ETHNOS360, INC.**, a Florida Not for Profit corporation, whose mailing address is 312 W. 1<sup>st</sup> Street, Sanford, Florida 32771, hereinafter referred to as “GRANTEE”.

**WITNESSETH:**

**WHEREAS**, by County Deed dated November 8, 2014, recorded in Official Records Book 8407, Pages 1742 through and including 1743 of the Public Records of Seminole County, Florida recorded on February 4, 2015 (the “Prior Deed”), GRANTOR intended to convey the Property, as described below, to GRANTEE; and

**WHEREAS**, question has now been raised as to the accuracy of the description of the real estate contained in the Prior Deed; and

**WHEREAS**, GRANTOR and GRANTEE now desire to correct and reform the Prior Deed in order to remove any question as to the description of the real estate intended to be conveyed by the Prior Deed.

**NOW, THEREFORE**, in consideration of the sum of Ten Dollars (\$10.00), cash in hand paid by GRANTEE to GRANTOR, and other good and valuable consideration, the receipt of which is hereby acknowledged, GRANTOR does hereby grant and convey unto GRANTEE, the following property:

LOTS 14, 15, AND 16, BLOCK M, FIRST STREET EXTENSION,  
ACCORDING TO THE PLAT THEREOF, AS RECORDED IN PLAT  
BOOK 3, PAGE 76, PUBLIC RECORDS OF SEMINOLE COUNTY,  
FLORIDA. (the “Property”)

GRANTOR executes this Corrective County Deed for the purpose of consenting to the reformation of the Prior Deed and agrees that the Property is the real estate intended to be conveyed by the Prior Deed, and will be effective as of, and retroactive to, the date of the Prior Deed.

This conveyance is made subject to easements, conditions, and restrictions of record insofar as the same may lawfully affect the property.
