Notice of Tax Certificate Sale Advertisement

Seminole County is seeking quotes from local newspapers to advertise the 2022 Delinquent Tax Notices.

Per Florida Statutes 197.402, the Board of County Commissioners shall select the newspaper in which the Tax Collector advertises the annual "Notice of Tax Sale".

The list of delinquent real property taxes must be advertised three times prior to the sale of the tax certificates and delinquent personal property taxes must be advertised one time, both utilizing parcel identification numbers or other identifying numbers (versus complete legal descriptions). Seminole County's 2022 delinquent real and personal property tax list will tentatively be advertised between the last week in April and the third week of May 2021. Based on a broadsheet newspaper (utilizing an 8-point font is preferred), the real property advertisement in recent years has been approximately 70 pages and the tangible personal property list has been 2 to 3 pages. The advertisements will need to be posted once a week for 3 weeks per Florida Statute 197.402.

A qualifying newspaper must meet statutory requirements for advertising legal notices pursuant to Florida Statutes 50.011, 50.031, 50.0211 and 50.061 -

- Publication once a week or more often
- 25% of the words in English
- Entered or qualified to be admitted and entered as periodicals matter at a post office in the county where published.
- For sale to the public
- Newspaper that has been an existence for at least one year
- Each legal notice must be posted on the newspaper's website on the same day that the printed notice appears in the newspaper, at no additional charge, in a separate web page titled "Legal Notices," "Legal Advertising," or comparable identifying language. A link to the legal notices' web page shall be provided on the front page of the newspaper's website that provides access to the legal notice.

- The publisher of any newspaper publishing all official public notices or legal advertisements shall charge therefore the rates specified in this section without rebate, commission or refund.
- The charge for publishing each such official public notice or legal advertisement shall be 70 cents per square inch for the first insertion and 40 cents per square inch for each subsequent insertion, except that government notices required to be published more than once whose cost is paid for by the government and not paid in advance by or allowed to be recouped from private parties may not be charged for the second and successive insertions at a rate greater than 85 percent of the original rate.

The publishers must have a Statement of Ownership which is filed annually by October 1st with the United States Postal Service. This document, form 3526, must be filed at the post office serving the publishers offices.
