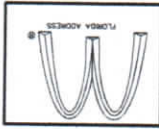

- Reconfigure parking area





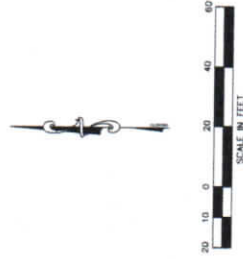
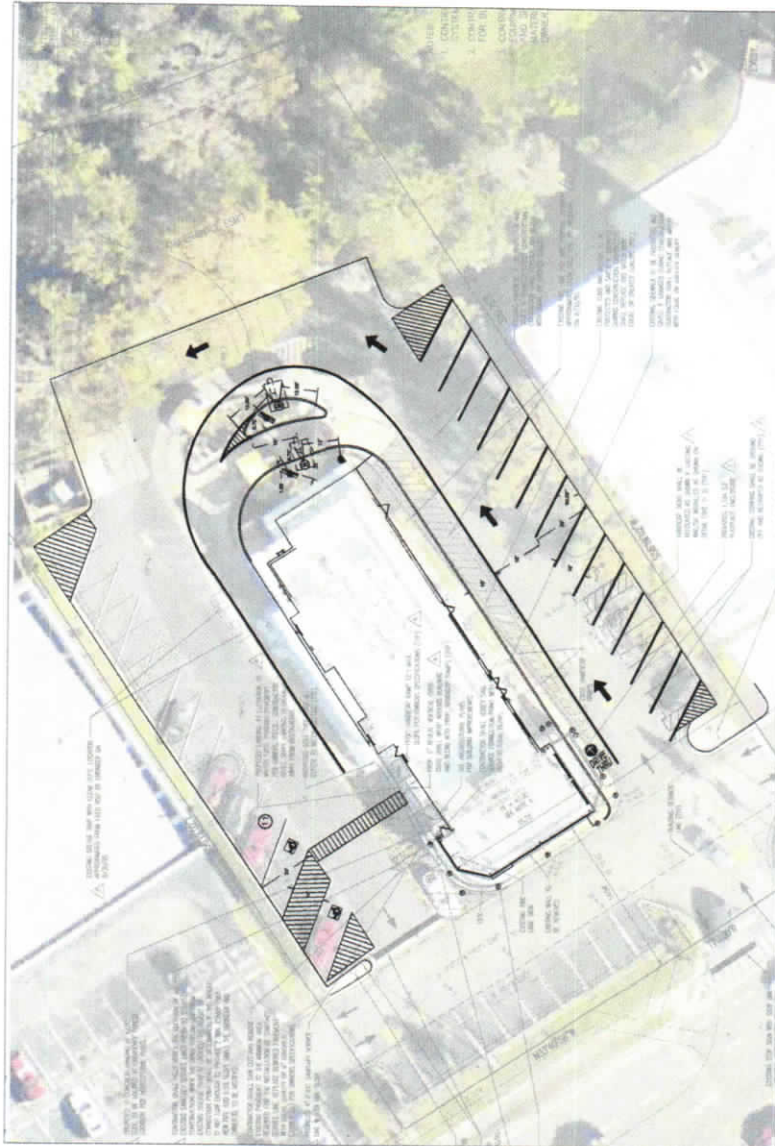
