Cassidy Perdue: 28

Ms. Lundy and Mr. Morris are both board certified civil trial lawyers with extensive experience representing governmental entities.

Ralph Caravello: 22

Firm has been in practice for 49 years. Many longstanding relationships with government entities: 25 years with Hernando County, 20 years with Orange County. Currently 24 full-time attorneys assigned to DRML. Unable to find required references in the RFP response.

Firm has been around since 1996 and appears to have been representing governmental entities since its inception.
