WHEREAS, COUNTY, SHERIFF, and FDLE, entered into the above-referenced Lease

Agreement on July 23, 2019, for lease of space

WHEREAS, the Seminole County Board of County Commissioners ("BCC") has the authority under Section 125.38, Florida Statutes (2023), to enter a private lease of real property with FDLE as an agency of the State of Florida if such lease is in the public or community interest and welfare and the leased property is not needed for a COUNTY purpose; and

WHEREAS, the BCC finds the subject Lease Agreement since its inception on July 23, 2019, is in the public or community interest and welfare and the leased property is not and has not been needed for a COUNTY purpose; and

WHEREAS, the parties desire to renew the Lease Agreement so as to enable both parties to continue to enjoy the mutual benefits it provides,

NOW, THEREFORE, in consideration of the mutual understandings and agreements contained herein, the parties agree to renew and amend the Lease Agreement as follows:

- 1. **RENEWAL.** The Lease Agreement is hereby renewed for the term of two (2) years from December 1, 2024 through November 30, 2026 with the same rental rate of One Thousand and NO/100 Dollars (\$1,000.00) per month.
  - 2. Section 25 of the Lease Agreement is deleted and replaced with the following:

Section 25. Notice. Any notice delivered with respect to this Agreement must be in writing and will be deemed to be delivered (whether or not actually received) when (i) hand-delivered to the person(s) designated below, or (ii) when deposited in the United States Mail, postage prepaid, certified mail, return-receipt requested, addressed to the person at the address for the party as set forth below, or such other address or to such other person as the party may have specified by written notice to the other party delivered in according to this section:
