A RESOLUTION PROVIDING FOR NAMING OF A STREET FROM UNNAMED RIGHT OF WAY TO SANDY FERN WAY IN ALTAMONTE SPRINGS, FLORIDA 32701; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, under the authority contained in Sections 336.05, Florida Statute (2024) and Chapter 90 of the Seminole County Land Development Code, the Seminole County Board of County Commissioners may name and rename streets and roads; and

WHEREAS, the Seminole County Board of County Commissioners has deemed it appropriate to name Unnamed Right of Way to Sandy Fern Way for consistency throughout County records; and

WHEREAS, the segment of Unnamed Right of Way to be named is wholly located within unincorporated Seminole County jurisdiction; and

WHEREAS, the proposed street name of Sandy Fern Way meets the standards for naming a street as required by Section 90.6 of the Seminole County Land Development Code; and

WHEREAS, this change is consistent with the overall County plans for street renaming, naming, addressing and the 911 system; and

WHEREAS, adoption of this Resolution will result in ten vacant properties address assignment, all other abutting property addresses are not affected; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA, THAT:

Section 1. Pursuant to Section 90.8 of the Seminole County Land Development Code, the segment of Unnamed Right of Way, as generally shown on the attached Exhibit "A" and as described below, is hereby named **SANDY FERN WAY**:

A REPLAT OF WINDWOOD PARK, PLAT BOOK 3, PAGE 30, DEPICTING UNNAMED RIGHT OF WAY ABUTTING LOTS 99, 100, 108-111, 121-127, 131- 133.

Section 2. This Resolution will become effective upon adoption by the
