

**SECOND AMENDMENT TO  
NON-EXCLUSIVE AMBULANCE FRANCHISE AGREEMENT**

**THIS SECOND AMENDMENT** is made and entered into this \_\_\_\_ day of \_\_\_\_\_, 2024, and is to that certain Agreement made and entered into on the 27th day of June, 2023, between **MEDFLEET LLC DBA ATI AMBULANCE** formerly known as **AFFORDABLE TRANSPORT INC.**, whose address is 12200 US Highway 19, Hudson, FL 34667, referred to as “**PROVIDER**”, and **SEMINOLE COUNTY**, a charter county and political subdivision of the State of Florida, whose address is Seminole County Services Building, 1101 E. 1<sup>st</sup> Street, Sanford, Florida 32771, referred to as “**COUNTY**” (“Agreement”).

**W I T N E S S E T H:**

**WHEREAS**, **PROVIDER** and **COUNTY** entered into the above referenced Agreement on June 27, 2023, to provide a non-exclusive ambulance service franchise for all the geographical territory of Seminole County, Florida to the residents of Seminole County, Florida, in accordance with Chapter 17 of the Seminole County Code; and

**WHEREAS**, the parties entered into the First Amendment to Non-Exclusive Ambulance Franchise Agreement on April 23<sup>rd</sup>, 2024 (“First Amendment”) to amend the Agreement to delete and replace Exhibit A; and

**WHEREAS**, “Medfleet, LLC dba ATI Ambulance” acquired Affordable Transport, Inc. on March 1, 2024; and

**WHEREAS**, the parties desire to amend the Agreement and First Amendment to replace Affordable Transport, Inc. with “Medfleet, LLC dba ATI Ambulance” as the **PROVIDER** under the Agreement; and

**WHEREAS**, Section 23 of the Agreement provides that any amendments will be valid only when expressed in writing and duly signed by the parties.

NOW, THEREFORE, in consideration of the mutual understandings and agreements contained in this Amendment, the parties agree to amend the Agreement as follows:

1. The "PROVIDER", as referenced in the Agreement and First Amendment, shall be "Medfleet, LLC dba ATI Ambulance, whose address is 12200 US Highway 19, Hudson, FL 34667". Affordable Transport, Inc. shall no longer be a party to the Agreement.

2. Medfleet, LLC dba ATI Ambulance hereby consents and agrees to be bound by the terms and conditions of the Agreement and First Amendment as the PROVIDER and assumes all obligations and responsibilities of the PROVIDER pursuant to the Agreement.

3. Section 24. Notices of the Agreement is hereby amended to provide the following information for PROVIDER:

4. Except as modified by this Second Amendment, all terms and conditions of the Agreement remain in full force and effect for the term of the Agreement. The Second Amendment, First Amendment and the Agreement shall be collectively referred to as the "Agreement".


