There are no outstanding claims of any nature, contractual or otherwise, or for any personal injury, death or property damage, arising from or associated with the performance of the work that might be the basis of any claim, suit, lien or demand that could be asserted against either Seminole County or the Contractor.
4. All Bonds and Insurance policies required by the Agreement are presently in effect and shall not be permitted to expire within the time periods stated in the Agreement documents.
5. This affidavit is made for the purpose of inducing Seminole County to make Final Payment, and acceptance of such Final Payment by the Contractor shall release Seminole County from any further liability under the Agreement documents.
