Holland & Knight LLP has extensive governmental experience and expertise in municipal bonds disclosures. They have been the County's Disclosure Counsel since 2001 and have a breath of resources of attorneys on staff with various expertise from environmental related experience to Water and Sewer and Solid Waste experience. In addition, they have 272 attorneys with governmental expertise.

Holland & Knight has institutional knowledge of Seminole County. Their methodology and approach to work was well presented in their presentation. They provided a 17 page presentation that listed the team members and the hypothetical scenario that the evaluation committee asked them to address for a potential issuance of Water and Sewer Revenue Bonds to finance a new water treatment facility. They discussed their approach with the County's refunding of the Water and Sewer Bonds in 2019. The Comptroller's Office and County staff have worked well with Holland & Knight. They are always responsive to questions. They review the County's annual Continuing Disclosure Report as well as reviewing the County's Post Issuance Monitoring Policies and Procedures. In addition, they keep the Clerk and County staff aware of any SEC rulings impacting Bond Issues. They conduct periodic training on municipal bonds.

It was difficult to assess if the clients they listed in their response were for Disclosure Services or Bond Counsel. NGN has worked with the County since 1985. They have served as Bond Counsel and helped develop various Bond Resolutions. It was difficult to assess their experience as it relates to Disclosure Counsel services. They have worked on multiple Bond Issues that are similar to some Bond Issues the County has previously issued.

Overall, the firm demonstrates a solid and well-structured methodology, in alignment with industry standards. That said, they appear lacking in distinctive innovative concepts that could set them apart. So while they provide a dependable and proficient service, the materials do not show an ability to provide creative and/or groundbreaking solutions. This is the main reason why I scored this firm lower.

David Shields: 20

Bond finance is a complex area of law that is not quickly understood by persons outside the field. The firm could have better explained their methodology by using and organized and structured PowerPoint in their presentation.

Jenny Spencer: 20

NGN's methodology and approach to work was not very cohesive as to how they would approach a project for Disclosure Services or the hypothetical scenario they were asked to address for the potential issuance of Water and Sewer Revenue Bonds to finance a new water treatment facility.
