Seminole County Code, Chapter 95, Sec. 95.4, as defined in Sec. 95.3 (c) Remains or rubble of a structure: *It shall be unlawful for any person to accumulate, dump or cause or allow to be accumulated or dumped or cause or allow to be placed, or otherwise to cause or allow to exist on any lands or premises any nuisance as defined in Section 95.3 (c) - Remains or rubble of a structure. This case was originally heard by the Code Enforcement Board on March 28, 2024, and an Order was issued giving the Respondent a compliance date of April 25, 2024.

On June 21, 2024, a letter was received from Rebuild Florida stating the Respondent had applied for the Rebuild Florida Housing Repair and Replacement Program (HRRP) for Hurricane Ian through the administration of the FloridaCommerce Agency.

June 27, 2024, the Code Enforcement Board issued an Order Finding Non-Compliance and Imposing Fine/Lien with a fine of \$3,200.00 for 63 days of non-compliance to continue to accrue at \$50.00 per day until brought into compliance.

An Affidavit of Compliance was filed by the Code Enforcement Officer after re-inspection on March 25, 2026.

The Administrative costs to process this case for the Clerk totals \$100.48.

On April 10, 2026, a Request for Reduction of lien application was filed by the Respondent, the fee of \$250.00 to process the application was paid.
