

RESOLUTION

of the

SEMINOLE COUNTY BOARD OF COUNTY COMMISSIONERS

A RESOLUTION SUPPORTING THE DESIGNATION OF THAT PORTION OF S.R. 46 BETWEEN SANFORD AVENUE AND E. LAKE MARY BLVD WITHIN SEMINOLE COUNTY'S JURISDICTION WITH ABUTTING PROPERTIES IN THE CITY OF SANFORD AS "MAYOR LARRY A. DALE MEMORIAL HIGHWAY"; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, former Mayor Larry A. Dale was a major force and a "larger than life" figure in the City of Sanford and served as the Mayor of the City of Sanford from 1997 through 2001 advancing the City of Sanford's growth and development, including significant contributions to the airport, the River Walk, and community partnerships that enriched local schools and facilities such as the aquatic center located at Seminole County School within the City of Sanford; and

WHEREAS, former Mayor Larry A. Dale, a longtime aviation devotee, subsequently served as President of the Orlando Sanford International Airport (SFB) from 2001-2018 and oversaw the renovation and expansion of SFB, which lead to profound economic development around the airport. Former Mayor Dale oversaw the introduction of Allegiant Airlines and the addition of nearly 100 flights at SFB, which tripled the airports assets and helped position the City of Sanford as a regional transportation hub; and

WHEREAS, Section 334.071, Florida Statutes, makes the installation of markers denoting honorary designation of transportation facilities contingent on the formal passage of a resolution of support by each affected local government prior to installation of the markers; and

WHEREAS, Chapter 2026-628, Laws of Florida, designates that portion of S.R. 46, located between Sanford Avenue and E. Lake Mary Boulevard located within Seminole County's

jurisdiction with abutting properties in the City of Sanford as “Mayor Larry A. Dale Memorial Highway” (“Designation”); and

WHEREAS, the roadway that is encompassed by the Designation is maintained by the Florida Department of Transportation (“FDOT”) and is located within Seminole County’s jurisdiction with abutting properties in the City of Sanford; and

WHEREAS, the effect of the Designation shall only require the placement of markers by FDOT at the termini or intersections specified above, and to provide authority for FDOT to place other markers as appropriate for the Designation; and

WHEREAS, the Seminole County Board of County Commissioners has reviewed the Designation and supports its adoption; and

WHEREAS, adoption of this Resolution will not result in any address changes, street name changes, or street sign changes for the road segment encompassed by the Designation; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA, THAT:

Section 1. The honorary designation of that portion of S.R. 46, located between Sanford Avenue and E. Lake Mary Boulevard located within Seminole County’s jurisdiction with abutting properties in the City of Sanford, is supported by the Seminole County Board of County Commissioners to be designated as “**MAYOR LARRY A. DALE MEMORIAL HIGHWAY.**”

Section 2. This Resolution will become effective upon adoption by the Seminole County Board of County Commissioners.
