SEMINOLE COUNTY BOARD OF COUNTY COMMISSIONERS

A RESOLUTION PROVIDING FOR AN HONORARY DESIGNATION TO ERECT SUITABLE MARKERS AS DESIGNATED IN CHAPTER 2024-278 FOR HOUSE BILL NO 389, SECTION 1 (5); SUPPORTING THE DESIGNATION OF A PORTION OF STATE ROAD 434 BETWEEN S.R. 400 AND RONALD REAGAN BOULEVARD IN SEMINOLE COUNTY AS "DEPUTY SHERIFF GEORGE PFEIL MEMORIAL HIGHWAY" TO BEGIN AND END IN LONGWOOD, FLORIDA 32750; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Section 334.071, Florida Statutes, makes the installation of markers denoting honorary designation of transportation facilities contingent on the Seminole County Board of County Commissioners passing a resolution in support of the honorary designation; and

WHEREAS, the Legislature's designation of a transportation facility is for honorary or memorial purposes or to distinguish a particular facility, and unless specifically provided for, shall not be construed to require any action by a local government or private party regarding the changing of any street signs, mailing address, or 911 emergency telephone number system listing; and

WHEREAS, Chapter 2024-278, Laws of Florida, designated that portion of State Road 434 between S.R. 400 and Ronald Reagan Boulevard in Seminole County as "Deputy Sheriff George Pfeil Memorial Highway" ("Designation"); and

WHEREAS, the effect of the Designation shall only require the placement of markers by the Florida Department of Transportation ("FDOT") at the termini or intersections specified above, and to provide authority for FDOT to place other markers as appropriate for the Designation; and

WHEREAS, the Seminole County Board of County Commissioners has reviewed the

Designation and supports the honorary designation for the "Deputy Sheriff George Pfeil Memorial

Highway"; and

WHEREAS, the road segment of the Designation is maintained by FDOT and is located

within Seminole County's jurisdiction abutting properties in the City of Longwood; and

WHEREAS, adoption of this Resolution will not result in any address changes, street name

changes, street sign changes for the road segment subject to the Designation; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY

COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA, THAT:

Section 1. The honorary designation of that portion of State Road 434, located within

and depicted on the attached map, between S.R. 400 and Ronald Reagan Boulevard in Seminole

County, is supported by the Seminole County Board of County Commissioners to be designated

as "DEPUTY SHERIFF GEORGE PFEIL MEMORIAL HIGHWAY."

Section 2. This Resolution will become effective upon adoption by the

Seminole County Board of County Commissioners.


