

RESOLUTION

of the

SEMINOLE COUNTY BOARD OF COUNTY COMMISSIONERS

PROVIDING FOR THE ADOPTION OF THE SEMINOLE COUNTY COMPREHENSIVE EMERGENCY MANAGEMENT PLAN; PROVIDING AUTHORIZATION TO THE EMERGENCY MANAGEMENT DIRECTOR OR HIS OR HER DESIGNEE TO MODIFY THE COMPREHENSIVE EMERGENCY MANAGEMENT PLAN; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, during, and in the immediate aftermath, of a natural, technological, or manmade disaster, many areas of Seminole County may require evacuation, sheltering, human services, infrastructure, critical special need medical services, logistical support, disaster housing, and other essential services; and

WHEREAS, pursuant to Section 252.38(1), Florida Statutes (2024), each county's local emergency management agency is tasked with establishing and maintaining disaster preparedness, response, recovery, and mitigation plans and programs countywide, to mitigate natural, technological, and manmade disasters; and

WHEREAS, Rule 27P-6.0023(1), Florida Administrative Code, expands upon the above-described directive and requires each county to develop a Comprehensive Emergency Management Plan (CEMP) and submit said plan to its governing body for formal adoption; and

WHEREAS, Seminole County's CEMP provides a framework for the development of detailed operating procedures for all County and support agencies charged with the responsibility of protecting the public's health and safety from natural, technological, and manmade disasters; and

WHEREAS, in order to optimize the efficacy of the County's disaster mitigation and

response efforts, it is desirous for the Emergency Management Director or his or her designee to be authorized to make modifications to the CEMP to promptly address any emerging unforeseen threat which warrants such a modification.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Seminole County, Florida that:

Section 1. Seminole County's Comprehensive Emergency Management Plan attached hereto and made a part hereof is hereby adopted and activated throughout Seminole County.

Section 2. The Emergency Management Director or his or her designee is hereby authorized to make modifications to the Comprehensive Emergency Management Plan in the event such modifications are necessitated by emerging unforeseen threats posed by a disaster event, in order to optimize the County's prompt response efforts.

Section 3. This Resolution shall become effective upon adoption by the Board of County Commissioners
