This TERMINATION OF EASEMENT (the "<u>Termination</u>") is made this _____ day of ____ 2025 by **FOUNDATION RE HOLDINGS LLC**, a Florida limited liability company ("<u>Foundation</u>"), whose address is 101 E. Colonial Drive, Orlando, Florida 32801, and **SEMINOLE COUNTY, FLORIDA**, a political subdivision of the State of Florida ("<u>County</u>"), whose address is Seminole County Services Building, 1101 East First Street, Sanford, Florida 32771.

WHEREAS, Syd Levy ("<u>Levy</u>"), as grantor, and County, as grantee, entered into that certain Drainage and Utility Easement on the October 1, 1987, and recorded on November 19, 1987, in Official Records Book 1907, Page 0358, Public Records of Seminole County, Florida (the "<u>Original Easement</u>"); and

WHEREAS, pursuant to that certain Temporary Blanket Drainage Easement (the "<u>Temporary Easement</u>") dated February 6, 2017, and recorded April 19, 2017, in Official Records Book 8896, Page 948, Public Records of Seminole County, Florida, the Temporary Easement replaced the Original Easement; and

WHEREAS, Foundation is the current fee simple owner of the real property encumbered by the Original Easement and the Temporary Easement (the "Property"); and

WHEREAS, the Temporary Easement provided that it shall terminate and be of no further force and effect upon the recordation in the Public Records of Seminole County, Florida, of a subdivision plat which includes the Property; and

WHEREAS, contemporaneously herewith, Foundation has caused the recording of the **REAGAN CENTER PLAT** (the "<u>Plat</u>") which includes the Property, and, accordingly, the Temporary Easement is to be vacated and replaced in favor of a dedicated Drainage Easement granted by the Plat;

NOW, THEREFORE, in consideration of the premises, the payment of TEN AND NO/100 DOLLARS (\$10.00) each to the other, and other good and valuable considerations, the parties do hereby agree as follows:
