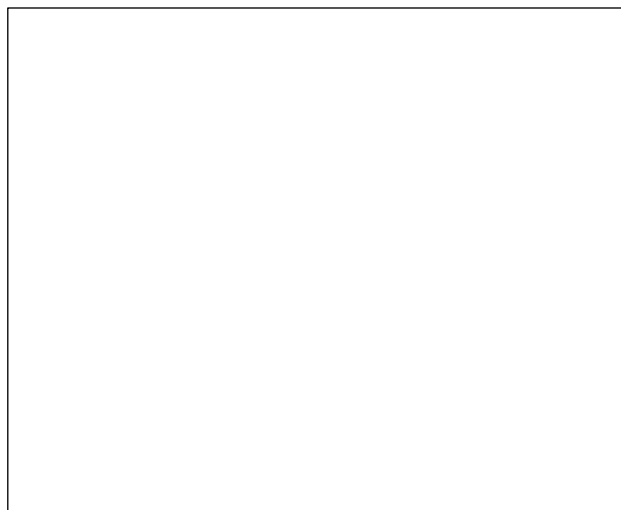

RELEASE OF RESTRICTIVE USE COVENANT

THIS RELEASE OF RESTRICTIVE USE COVENANT (“Release”) is made this _____ day of _____, 20_____, by **SEMINOLE COUNTY**, a political subdivision of the State of Florida, whose address is Seminole County Services Building, 1101 E. 1st Street, Sanford, Florida 32771, hereinafter referred to as “COUNTY”.

RECITALS

WHEREAS, the real property located at 2261 Greenway, Sanford, Florida 32771, (the “Property”) the legal description and parcel identification for which are as follows:

is burdened and benefited by that certain Restrictive Use Covenant (the “Covenant”) dated October 7, 2022, as recorded in the Official Records Book 10344, Pages 1312 through and including 1314, Public Records of Seminole County on November 8, 2022.

WHEREAS, the use of the Property was restricted to providing affordable housing for Low and Moderate Income households for a period of thirty (30) years from the date of recording of the Covenant in the Official Land Records of Seminole County (the “Affordability Period”); and

WHEREAS, the Covenant is for the benefit of COUNTY and may be released prior to the expiration of the Affordability Period only upon the consent of COUNTY; and

WHEREAS, COUNTY desires to clear title and release and extinguish all rights and obligations of the Covenant,

NOW, THEREFORE, in consideration of the foregoing and for the purposes of clearing title, COUNTY agrees that all benefits, burdens, rights, and obligations arising from the Covenant are hereby forever released and extinguished.
