

**FINAL RENEWAL TO LEASE AGREEMENT
WITH ADDICTION RECOVERY AND TREATMENT CENTER**

THIS FINAL RENEWAL TO ADDICTION RECOVERY AND TREATMENT CENTER LEASE AGREEMENT ("Final Renewal") is made and entered into this 27 day of August, 2024, and is to that certain Lease Agreement made and entered into on the 2nd day of March 2020, as amended on September 28, 2021 and renewed on November 14, 2023, between **SEMINOLE COUNTY**, a charter county and political subdivision of the State of Florida, whose address is Seminole County Services Building, 1101 East 1st Street, Sanford, Florida 32771, in this First Renewal referred to as "LANDLORD," and **ADVENTIST HEALTH SYSTEM/SUNBELT, INC.**, a Florida not-for-profit corporation doing business as **ADVENTHEALTH HOPE AND HEALING CENTER**, whose address mailing address is 900 Hope Way, Altamonte Springs, Florida 32714, in this Final Renewal referred to as "TENANT."

WITNESSETH:

WHEREAS, LANDLORD and TENANT entered into the above referenced Lease Agreement on March 2, 2020, as amended on September 28, 2021 and renewed on November 14, 2023, for the lease of certain property beginning on the date that TENANT took possession of the Leased Premises and ending December 31, 2024 (the "Lease Agreement"); and

WHEREAS, the Lease Agreement, as amended, provided for two additional renewal periods each consisting of a one-year term; and

WHEREAS, the parties desire to renew the Lease to enable both parties to continue to enjoy the mutual benefits it provides; and

WHEREAS, the parties have determined that it would be in their best interest to continue rather than terminate this Lease Agreement,

2. The Lease Agreement is hereby renewed for the term of one year from January 1, 2025 through December 31, 2025, unless terminated sooner as provided for in the Lease Agreement.
3. Except as provided in this Final Renewal, all terms and conditions of the Lease Agreement, as previously amended, remain in full force and effect for the term of this Renewal.
