## MUTUAL TERMINATION OF AGREEMENT BETWEEN SEMINOLE COUNTY AND RESCUE OUTREACH MISSION OF CENTRAL FLORIDA, INC. FOR AMERICAN RESCUE PLAN ACT FUNDING

THIS MUTUAL TERMINATION OF AGREEMENT is made and entered into this 31st day of October, 2023, by and between RESCUE OUTREACH MISSION OF CENTRAL FLORIDA, INC., whose address is 1701 Historic Goldsboro Boulevard, Sanford, Florida 32771, in this Mutual Termination of Agreement referred to as "SUBRECIPIENT," and SEMINOLE COUNTY, a charter county and political subdivision of the State of Florida, whose address is Seminole County Services Building, 1101 East 1st Street, Sanford, Florida 32771, in this Mutual Termination of Agreement referred to as "COUNTY".

## WITNESSETH:

WHEREAS, on December 14, 2021, the parties entered into an Agreement for provision of eligible expenditures under the American Rescue Plan Act, as amended on January 24, 2023, (in this Mutual Termination of Agreement referred to as the "Agreement"); and

WHEREAS, COUNTY and SUBRECIPIENT have mutually determined it is in their best interest to terminate the Agreement; and

WHEREAS, SUBRECIPIENT acknowledges and agrees that while the parties under the Agreement intend to mutually terminate the Agreement, SUBRECIPIENT agrees to continue providing complete documentation, as required by COUNTY, to account for all funds provided under the Agreement,

## NOW, THEREFORE,

1. The foregoing recitals are true and correct and form a material part of this Mutual Termination of Agreement upon which the parties have relied.

- 2. SUBRECIPIENT and COUNTY hereby agree that the Agreement is hereby retroactively terminated effective October 1, 2022.
- 3. SUBRECIPIENT acknowledges and agrees that COUNTY does not owe SUBRECIPIENT any further funding payments under the Agreement.
