

**SECOND AMENDMENT TO MEMORANDUM OF UNDERSTANDING
REGARDING THE BILL NYGREN CARRIAGE COLLECTION**

THIS SECOND AMENDMENT is made and entered into this 22 day of September, 2022 and is to that certain Memorandum of Understanding (MOU) made and entered into on the 20th day of September, 2018, as amended on July 28, 2020, between **SEMINOLE COUNTY**, a political subdivision of the State of Florida, whose address is 1101 E. 1st Street, Sanford, Florida 32771, in this Amendment referred to as "COUNTY", and **SEMINOLE COUNTY HISTORICAL COMMISSION**, a voluntary advisory board comprised of members appointed by the Board of County Commissioners of Seminole County, in this Amendment referred to as "HISTORICAL COMMISSION", and **SEMINOLE COUNTY HISTORICAL SOCIETY, INC.**, whose address is 300 Eslinger Way, Sanford, Florida 32773, in this Amendment referred to as "HISTORICAL SOCIETY".


WITNESSETH:

WHEREAS, the parties entered into the above referenced MOU on September 20, 2018, as amended on July 28, 2020, to set forth the terms and understanding between COUNTY and HISTORICAL SOCIETY and HISTORICAL COMMISSION to prepare for the donation of the Bill Nygren Carriage Collection; and

WHEREAS, the parties desire to amend the MOU in order to extend the term of the MOU and to enable both parties to continue to enjoy the mutual benefits the MOU provides,

NOW, THEREFORE, in consideration of the mutual understandings and agreements contained in this Amendment, the parties agree to amend the MOU as follows:

1. Section 7 of the MOU is amended to read as follows:

Section 7. Term. This MOU shall terminate September 20, 2025.



2. Except as modified by this Second Amendment, all terms and conditions of the original MOU, as previously amended, remain in full force and effect for the term of the MOU.




