Dear Agency Representative,

The Florida Department of Transportation (FDOT) District Five is soliciting applications for the FY2026/2027 Public Transit Service Development Program Funding. This program was enacted by the Florida Legislature to provide initial funding for special transportation related projects.

### Applicant Eligibility:

Eligible recipients are public agencies providing or implementing public transit services directly or through contractual agreements. "Public transit" is defined as the transport of people by conveyances or systems of conveyances, traveling on land or water, local or regional in nature, and available for use by the public. This definition is not limited to traditional scheduled fixed route service but may also include demand response or other modes which are open to shared ride use by the general public. Community Transportation Coordinators (CTCs) which are public agencies are eligible recipients. A private entity may provide the local match for the project (i.e., serve as a project sponsor), but the applicant must be a public entity. The public entity is ultimately responsible for stewardship of the award and its outcomes.

#### **Program Purpose:**

The main goal of the program is to determine whether a new or innovative technique or measure can be used to improve or expand public transportation. Service Development projects specifically include the use of new technologies, services, routes or vehicle frequencies; the purchase of special transportation services and other techniques for increasing service to the riding public; and new technologies or methods for improving operations, maintenance and marketing. However, priority will be given to those projects that have the potential to benefit other transit systems and that have not been undertaken by other agencies.
