

RESOLUTION

SEMINOLE COUNTY BOARD OF COUNTY COMMISSIONERS

APPROVING AND AUTHORIZING THE CHAIRMAN TO EXECUTE A LOCALLY FUNDED AGREEMENT AND THREE-PARTY ESCROW AGREEMENT WITH THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION RELATING TO THE CROSS SEMINOLE TRAIL OVERPASS/PEDESTRIAN CONNECTION AT U.S. 17/92 PROJECT (FINANCIAL PROJECT NUMBER 441484-2-62-01); AUTHORIZING THE COUNTY MANAGER OR DESIGNEE TO EXECUTE RELATED IMPLEMENTING DOCUMENTS, SUBJECT TO REIVEW AND APPROVAL BY THE COUNTY ATTORNEY’S OFFICE; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the State of Florida, Department of Transportation (FDOT), is undertaking the Cross Seminole Trail Overpass/Pedestrian Connection at U.S. 17/92 Project, identified as Financial Project Number 441484-2-62-01 (the “Project”); and



WHEREAS, the Project will improve pedestrian and trail connectivity and promote public safety and multimodal transportation opportunities within Seminole County; and

WHEREAS, FDOT has requested Seminole County participate in funding a portion of the Construction Engineering and Inspection (CEI) costs associated with the Project through a Locally Funded Agreement; and

WHEREAS, the parties also desire to enter into a Three Party Escrow Agreement with the State of Florida Department of Financial Services, for the establishment and administration of an escrow account associated with the Project; and

WHEREAS, Seminole County desires to participate in funding a portion of the CEI costs for the Project, subject to the terms and conditions contained in the Locally Funded Agreement and related escrow documents; and

WHEREAS, the Board of County Commissioners finds that entering into the Locally Funded Agreement and Three Party Escrow Agreement is in the best interests of Seminole County.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Seminole County, Florida, as follows:

1. Approval of Agreements. The Chairman is hereby authorized to make, execute, and deliver to the State of Florida, Department of Transportation a locally funded agreement (LFA) between the State of Florida Department of Transportation and Seminole County, relating to the Cross Seminole Trail Overpass/Pedestrian Connection at U.S. 17/92 Project, Financial Project Number 441484-2-62-01.

2. Authorization for Implementing Documents. The County Manager or designees is authorized to execute any related escrow forms, payment documents, certifications, and other implementing documents necessary to carry out the purposes of the Locally Funded Agreement and Three-Party Escrow Agreement, subject to review and approval by the County Attorney's Office.

3. Effective Date. This Resolution shall take effect immediately upon its adoption.
