## OF THE SEMINOLE COUNTY BOARD OF COUNTY COMMISSIONERS RECOGNIZING UNITED STATES AIR FORCE SENIOR TECHNICAL SERGEANT DANNY MCKINNEY FOR HIS OUTSTANDING SERVICE TO THE UNITED STATES AND SEMINOLE COUNTY

**WHEREAS**, the brave men and women of our Army, Navy, Marines, Air Force, Coast Guard, and Space Force demonstrate a resolute spirit and unmatched selflessness, reminding us there are few things more American than giving of ourselves to make a difference in the lives of others; and

WHEREAS, Technical Sergeant Danny McKinney served in the Command Post with service during the Gulf War era. The highlight of his career was the three(3) Air Force Commendation Medals he earned for superior performance of his duties. He also earned various other medals including the Joint Service Achievement Medal and the Air Force Good Conduct Medal with 5 devices; and

WHEREAS, Technical Sergeant Danny McKinney retired from the Air Force and then began working for Seminole County as a 911 Operator until he retired again in 2015. While active in the community, he served as President of Oviedo Citizens in Action from 2001 to 2011, and Treasurer since 2015. He is currently involved with the Improving Oviedo Neighborhood Committee and is involved with the Missionary Baptist Church in Oviedo; and

**WHEREAS,** Technical Sergeant Danny McKinney has brought great credit and distinction upon himself, the United States of America, the United States Air Force, and Seminole County.
