WHEREAS, the lease dated July 24, 2018, provides for a five-year original term commencing effective July 23, 2018 and ending July 22, 2023, and two successive renewal periods not to exceed five (5) years each; and

WHEREAS, the parties desire to renew the Lease to enable both parties to continue to enjoy the mutual benefits it provides,

NOW, THEREFORE, in consideration of the mutual understandings and agreements contained in this Lease, the parties agree to renew the Lease as follows:

- 1. The foregoing recitals are true and correct and form a material part of this First Renewal upon which the parties have relied.
- 2. The Lease is hereby renewed for the term of five (5) years from July 23, 2023 through July 22, 2028, unless terminated sooner as provided for in the Lease.

3. Pursuant to Section 4 of the Lease, the parties acknowledge that the rental for the payment for the Lease term commencing July 23, 2023, and ending July 22, 2028, for the Leased Premises will be an annual sum of ONE AND NO/100 DOLLARS (\$1.00), as provided in the Lease.
