Chapter Introduction – General Notes

190.201 Legislative intent/use of Acquired Lands by the public.

1. Nothing in this ordinance will preclude a privately led initiative (Zembower)

√ Staff added language in section 206 (e), page 8 of 15, Dedicated Funding of Seminole Forever to reflect this request.

2. What are the seven cities doing and would they be willing to partner with us (All commissioners)

NEXT STEPS

3. What is the plan (30/30 plan)? (Dallari)

√FOR DISCUSSION

- This does not affect the ordinance and will be further addressed later.
- Staff will investigate and provide insight into this type of conservation plan.
- o The "30 by 30" conservation plan: https://wildlife.org/administration-releases-30-by-30conservation-plan/
 - Proposes to conserve at least 30% of all lands and waters by 2030
 - Recently a figure of 30% has been posed which includes lands and waters. Taking that into consideration Seminole at approx. 50% would appear to be in good shape!? If we go with 30% land area that would mean an additional 20,000 acres to move into conservation. Not sure there's that much available if you add up the remaining large landowner properties.
 - o Currently 20% of Seminole County land is preserved 44,000 acres; but with wetlands and flood prone areas, it's over 100,000 acres, or 50% of Seminole County
- 4. Wants Hanson to weigh in on the sustainability this is the 30/30 plan how much land should we preserve in Seminole County? (Dallari)

190.2076 Dedicated Funding of Seminole Forever.

 Under Sec. 190.207 – we are funding this program and providing other supplemental funding sources (it would be good to point out that all of these "supplemental" funding sources are applied for and not guaranteed) (Constantine, Lockhart, Herr)

 - 1 parcel from Spring Hammock Preserve 29.65 acres

 - 3. Connectedness to other conservation lands,
 - 4. Use potential for passive recreation or education
 - 5. Special considerations including strong public interest.
- 3. Consider a provision for protecting farmers (Zembower)

NEXT STEPS

 $\sqrt{}$ Natural Resources Conservation Service and Florida Department of Agriculture were included as alternative funding sources.

 $\sqrt{\text{Section } 190.201}$ allows for farmland to be incorporated into this program.
