SS-604841-24/TLR will provide for the purchase of three (3) Fotokite Sigma drones from Ten-8 Fire & Safety, LLC which is the only authorized distributor of the Fotokite-Brand in Florida.

The Fire Department selected this product due to the unique design and use. The Fotokite Sigma drone can be rapidly deployed on an emergency scene within 2

minutes and does not require constant supervision. This purchase includes three (3) Fotokite rugged command tablets with live application windows OS, remote video streaming, a subscription for one (1) year and on-site operator training.
