Background:

This parcel (No. 1-867) has been identified as being needed for a drainage easement necessary for the County's Midway Drainage Improvement Project. The owner (Droopatee Seegolam / Tax ID No. 33-19-31-507-0000-1360) of the property located

on the west side of Jitway, approximately 200± feet (0.03 miles) south of Midway Avenue, in Sanford, Florida, has agreed to sell and convey this drainage easement to Seminole County for the sum of \$4,920.00, inclusive of all fees and costs.

The parent property is vacant and consists of 0.10± acres of land. The County's valuation of this acquisition is \$2,600.00, a portion of which includes the cost to cure to make the owner whole. The County's incentivized offer amount was \$4,920.00, which was accepted by the owner, inclusive of all fees and costs.
